- Group 1:** **MERIT GROUPS** - Recreation programs, quasi-recreation groups, i.e. Boy Scouts, Girl Scouts, youth groups, etc.
- Group 2:** **GOVERNMENT OR NON-PROFIT GROUPS** - Public Non-Profit groups and organizations, i.e. clubs and associations which are determined to be for the general welfare of the community; cultured arts activities that have a prime objective of civic or recreational nature.
- Group 3:** **PRIVATE** - Weddings, receptions, private parties, business groups, functions for profit, also non-profit group sponsored private parties.

Events that include alcohol may reflect a higher deposit

- Owned by Placer County. Operated and maintained by TCPUD. Includes 2 playgrounds, 3 picnic areas, small amphitheater, 6 heated bathrooms, group bbq area, running water, 2 electrical plug-ins, parking and historic jail.
- Available: 8:00 a.m. to 10:00 p.m.
- Parking: Lower lot 43 spaces, Upper lot 24 spaces
- Music: Amplified music is not allowed
- Garbage: Must haul out garbage. Dumpsters can be ordered from Tahoe Truckee Disposal Company at (530) 583-0148
- Pets: No pets are allowed on Commons Beach. This is enforced by Placer County Animal Control.
