Lake Tahoe Outlet Improvements: Lakeside Trail Crossing Dedicated to Community Service

On July 25, 2005, local citizens, county officials, and Federal and State agency representatives, gathered at the ribbon-cutting ceremony for this remarkable project. During the ceremony two individuals were honored for their significant contributions.

Longtime resident Bill Briner was recognized for his key role in encouraging the State to acquire the property at both sides of the dam from private ownership. The opportunity for public improvements at this important site was driven by his vision and determination. Although the site was acquired in 1978, it was subject to long term private leases for another 25 years. Some officials at the State level were not enthusiastic about the opportunity. Bill's vision, determination and commitment to Lake Tahoe were essential to the acquisition.

California Assembly Member Tim Leslie was recognized for providing 20 years of leadership and support to the citizens of North Lake Tahoe. He secured the initial funding to implement an improvement project to help with traffic congestion and public access at the Tahoe City "Y". Tim served as our representative in the State Assembly and in the State Senate for a combined total of twenty years. During these decades of public service,

TCPUD IMPROVEMENTS FOR OUR COMMUNITY

Lakeside Trail Crossing at the Dam

Completion of the initial phase of this project occurred this summer, with the crossing behind the dam operational on July 25, 2005. It has met with overwhelming community support and appreciation. The second phase of the project has been delayed until next year since no bids were received this summer. We are currently in the bidding process again, with the plan of starting construction next year.

Sequoia Crossing

The trail safety project is expected to be complete by November 1, 2005. The project scope involves: lowering the trail grade to 5% for approximately 300 linear feet; increasing vehicle sight distance of the crossing; and construction of retaining walls and slope stabilization. The most visible part of the project will be the flashing warning signs for motorists located 500

and 250 feet in advance of the crossing in both directions. These will automatically activate when trail users pass electronic detection devices.

Highlands Water Tank and Water Distribution Lines

This project is on-schedule for operation by March 2006 and completion of revegetation of the site by July, 2006. The project includes construction of a new 1.2 million steel water tank, a booster pump station, and water line from our existing distribution system to the tank. Due to the increased water pressure that will effect some of the Highlands subdivision, pressure-reducing valves (PRV's) will need to be installed at certain residences. TCPUD will be implementing these installations and expect to be completed by the end of October.

General Winterization GUIDELINES

Significant property damage and thousands of gallons of water can be wasted from frozen water pipes. Here are some general guidelines to prevent frozen pipes:

- When not occupied, shut off the water to the house and drain all the internal piping
- Never run bleeder lines or trickle small amounts of water out of fixtures to prevent freezing. This practice is in violation of TCPUD Ordinance 185 and is an enforceable violation
- Close crawl space vents to avoid drafts
- Locate and mark the water shut off box at the street with a stake
- Locate and mark sewer cleanouts
