TCPUD Customers Have Conserved Water!

Since drought mandates went into effect, customers have exceeded State goals saving 25%! Since the beginning of the yer TCPUD customers have saved 45 million gallons of water!

Continue to Save Water and Money – WIN/WIN!

Under our current Stage 2 Drought Response Declaration, the Tahoe City Public Utility District is encouraging water conservation. Easy ways to save water IN your home include: checking for water leaks (including your toilet), taking shorter showers, not letting the faucet run when washing dishes or vegetables, watering your yard only when needed and when it is not windy or hot, and using water only when necessary. In 1947 TCPUD took over local maintenance of Commons Beach, and in 1969 a community survey added recreation services.

Proposed 5-year Maximum Water & Sewer Rate Schedule

In 2009, the District approved a 5-year maximum schedule for both water and sewer rates. Due to significant efforts to control costs, TCPUD never charged the approved maximum water or sewer rates. Current water rates are 19% and sewer rates are 24% below the approved maximum rate.

Per Proposition 218's requirements, it is now time for a re-evaluation of the rates. TCPUD is asking customers to re-approve the previous 2009 maximum sewer rate schedule, phased in more slowly over the next 5 years. For water rates, typical customers would remain under the previous 218 approval until 2018 and in 2019 there would be an additional 5.6% increase. This allows for slower, steadier rate increases versus the more aggressive approach approved in 2009. The rates are focused on providing ½ of the funds needed for infrastructure investment and rehabilitation. The other ½ will come from a combination of property taxes, grants and potential borrowing.


There will be two public workshops to review the rate study and proposed rates: Tuesday, October 16, 2014 from 6pm - 7:30pm and Friday, October 17, 2014 from 12pm - 1pm at the District office. Additionally, the TCPUD Board of Directors invites the public to attend a scheduled public hearing on Friday, November 21, 2014 at 8:30am to consider the adoption of this new rate schedule.

Get involved in TCPUD's 2015 Budget Planning Process

It's that time of year again when the TCPUD begins developing its budget and goals for 2015. Every person at the TCPUD, from front line staff to the Board of Directors understands that we are entrusted to steward the taxes and fees you provide. Fiscal accountability is a core value of the District and as such, we look for the most cost effective and efficient ways to provide you services. The below chart illustrates the budget over the last 5

years. Cost controls and efforts have kept the budget under 2% growth over the last 5 years, despite increases in many of the mandates, supply, and material costs. TCPUD is holding a budget workshop on Tuesday, November 4th at 4pm in the TCPUD Board Room. Your input is important.

Lake Forest Boat Ramp Update

The Lake Forest Boat Ramp Rehabilitation project began September 8th and is expected to run through December. The ramp was constructed in 1963 and after 51 years has significant structural deterioration. This \$1.1 million dollar project is predominately funded by grants received from the Wildlife Conservation Board (75%) and the North Lake Tahoe Resort Association (11%). Once completed, the ramp may reopen as early as January 2015.

Winter Sports Park

The Tahoe City Winter Sports Park, located at the Golf Course in downtown Tahoe City, now offers 3km of groomed cross country ski trails, a family sledding hill, and rentals for XC skiing, skate skiing, and snowshoeing. Dogs are welcome. Conveniently located just behind town, the Winter Sports Park has something for the whole family, as well as a restaurant and bar in the clubhouse/day lodge.
