

Tahoe City Public Utility District 2023 Madden Creek Water System - Annual Water Quality Consumer Confidence Report

To Our Valued Madden Creek Customers:

The enclosed information is a report of the quality and laboratory analysis of the drinking water for the Madden Creek Water System during the calendar year of 2023. On page two you will find a table showing data from samples collected and contains all detected contaminants in the water, as well as general information on water quality and different standard health effect language for various contaminants. While water supplied to Madden Creek is classified as either treated surface water or groundwater, it is important for you to understand all potential sources of drinking water. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the U.S. EPA's Safe Drinking Water Hotline (1-800-426-4791). Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. U.S. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (1-800-426-4791).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants such as salts and metals that can be naturally occurring or result urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and Herbicides, that may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants including synthetic and volatile organic chemicals that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- Radioactive contaminants that can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the U.S. Environmental Protection Agency (U.S. EPA) and the State Water Resources Control Board (State Board) prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The State Board regulations also establish limits for contaminants in bottled water that provide the same protection for public health.

Detected Compounds The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old. If a substance or contaminant is not listed, it is either not detected above the detection limit in our sources or not required to be reported or sampled.

Where does your water come from?

In 2023 approximately 96.3% of the water supplied to the system was from the Silver Street Well and the remaining 3.7% came from the McKinney/Quail system, through the interconnection on South Street. All of the drinking water supplied to this water system this year was classified as groundwater. The groundwater sources are wells drilled deep into the ground, providing clean, high quality water that consistently meets all standards without significant treatment. The Madden Creek Water System serves all residents from Cherry Street to Tahoe Ski Bowl Way in Homewood, CA. There have been no contaminants detected in the water supply, however the sources are still considered vulnerable to the activities located near the drinking water source. Well construction and security measures should provide protection from most contaminating activities. Copies of all source water assessments are available for review at the TCPUD offices during regular business hours. Health Effects and General Information

Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. TCPUD is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you do so, you may wish to collect the flushed water and reuse it for another beneficial purpose, such as watering plants. If you are concerned about lead in your water, you may wish to have your water tested. - AL Regulatory Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.
- E.C. Electrical Conductivity
- MCL Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. Primary MCLs are set as close to the PHGs (or MCLGs) as is economically and technologically feasible. Secondary MCLs are set to protect the odor, taste, and appearance of drinking water.
- MCLG Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs are set by the U.S. Environmental Protection Agency.
- MRDL Maximum Residual Disinfection Level: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- MRDLG Maximum Residual Disinfection Level Goal: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

- ND Not Detected: Not detected above the detection limit for purposes of reporting.

- NTU Nephelometric Turbidity Unit: Measure of water clarity using light scattering

- ppb parts per billion or micrograms per liter (ug/l): Parts contaminant for every 1 billion parts of water.
- ppm parts per million or milligrams per liter (mg/l): Parts contaminant for every 1 million parts of water.

- SDWS Secondary Drinking Water Standards. Secondary MCLs are set to protect the odor, taste, and appearance of drinking water.
