

Kayak & Paddle Board Storage Racks | How-To Register


Kayak and Paddle Board Storage Racks open enrollment begins:

- Wednesday, May 1 for any available slots for Residents and Non-Residents
- * Resident refers to customers that live and/or own property in the Tahoe City Public Utility District service area.





STORAGE RACK CONTRACT, TERMS, AND CONDITIONS

1. I understand that Tahoe City Public Utility District operates and maintains Commons Beach, Skylandia Park and Lake Forest Beach.
2. I understand storage slots are non-transferrable and refunds will not be issued. Abuse of storage rack may result in revocation of storage slot at the discretion of the TCPUD Parks and Recreation Department and without recourse or refund.
3. I understand and agree that any loss, theft, or vandalism of personal property and expense thereof, as a result of my use of the storage rack, is my responsibility and do hereby release and hold harmless the Tahoe City Public Utility District from any claim. The Tahoe City Public Utility District is renting me a storage space for the sole purpose of storing my kayak or paddleboard for a Season, which is from May 1 – October 31.
4. I agree to provide a lock and cable to secure my kayak/paddleboard to the storage rack. Additionally, I agree to remove the lock and kayak/paddleboard from my storage rack by the end of the day on October 31 (weather permitting), otherwise my lock and kayak/paddleboard will be removed by TCPUD and I will be billed a \$25 removal fee. After 45 days, all equipment becomes the property of TCPUD and will be disposed of accordingly. All outstanding balances on accounts must be paid before the next season storage rack rental.
5. I understand only standard sized kayaks/paddleboards are allowed to be stored in our kayak racks. Canoes and boats are not permitted. The storage of two pieces of equipment is permitted as long it is paid for, has a current sticker and it does not impede the use of adjacent racks by other renters.
6. I understand that my name must appear on the records as the storage space holder. Rented storage spaces cannot be transferred or sublet to other individuals and I understand that doing so may result in permanent revocation of my storage space privileges without refund.
